The main market area is Finland, but the company has gained a growing number of customers in the Baltic countries and Sweden. The main suppliers are located in Europe with some suppliers in the USA and Asia.

The headquarters as well as departments for chemicals, energy and components are located in Espoo, Finland. The steel service center is placed in Valkeakoski.
